

ABBAsol

Ready-to-use product

Designed to keep exterior patios clean by way of decontamination. It acts on mosses, algae and lichens without any harm on the surfaces. Biodegradable 98 %.

APPLICATION FIELD

ABBAsol is designed to clean and preserve all types of tile materials without any harm on surfaces. It can be used on a wide range of materials: Natural or tinted concrete, natural or processed stones, pebbles or granite finished materials, paving stones, terracotta, ceramic tiles, wood, etc.

HOW TO APPLY

ABBAsol must be applied upon dry materials and at temperatures of min. +3°C. Over high heat with direct sunlight ABBAsol should not be used (danger of evaporation).

We recommend two methods of application:

1. Pre-cleaning of the surfaces with a high pressure cleaner (be careful, too high pressure can damage the surface). Then ABBAsol is applied undiluted. The surface should be moist, but no pools of water. Protect the treated area 24 hours against rain.
2. Moisten the surface (Without creating pools of water). ABBAmousses can be easily sprayed or applied with a brush or a roller. We suggest Birchmeier brushes (available with us). Protect the treated area 24 hours against rain.

Never rinse the treated surfaces with water.

Rinse tools after use with water. For a faster result the treated area can be brushed with a mixture of 1 liter water and 10 liters of ABBAsol after an action time of 60 minutes. In case of very dirty areas, we recommend a pretreatment with ABBAClean. As additional protection ABBAsol hydrofuge or ABBAsol hydro-oléfuge can be applied.

Consumption: 1 Litre per approximately 5m² / 0,2 Litre/m² depending on the porosity and contamination of the underground.

When applied correctly, ABBAsol is not harmful. Observe normal safety regulations.

STORAGE AND EXPIRATION

Can be stored for several years in its original packaging and protected against frost. Keep away from foodstuffs, beverages and animal feed. Do not store in metal containers because the aqueous solution could form rust.

Disposal: Avoid spilling in ponds or streams as ABBAmousses may be harmful for aquatic fauna. Rinse tools after use with water. Do not empty into drains. Dispose of only completely emptied containers.

COMPOSITION

Prepared on the basis of quaternary ammonium salt in aqueous solution. ABBAmousses does not contain chlorine, sulfate or acid. Active substance: Quaternary ammonium compound, Benzyl-C12-18-alkyldimethyl-, Chloride 18,8 mg/g, PH value 7
