

ABBAClean

Ready-to-use product

ABBAClean is a product designed to clean walls and roofs which are encrusted with dirt and micro-organisms (moss, algae, lichens, red traces). Biodegradable 98 %.

APPLICATION FIELD

ABBAClean cleans walls, facades and roofs from pollution and eliminates micro-organisms (moss, algae, lichen, red traces). ABBAClean is well suited for cleaning roofs with partially strong lichen growth. This treatment can be followed by normal operations like painting or treatment with ABBAmousses after 1 hour. ABBAClean is applied on:

Roofs:	terracotta tiles, slates, fibrocement, etc.
Walls:	all kind of renderings, roughcasts, stone and brickworks, etc.
Others:	patios, monuments, conservatories, paths, benches, tennis courts, etc.

HOW TO APPLY

ABBAClean can be easily sprayed or applied with a brush or a roller. ABBAClean must be applied upon dry or slightly damp materials (morning dew) and with no risks of rain for at least 24 hours and at temperatures of min. +3°C. We suggest Birchmeier brushes (available with us). Over high heat with direct sunlight ABBAClean should not be used (danger of evaporation).

ABBAClean is well suited for cleaning roofs with partially strong lichen growth. Leave ABBAClean **4 to 24 hours** (depending on the porosity and contamination of the underground.) Protect surface from rain for at least 24 hours and use ABBAClean at temperatures of min. +3°C. Treat with brush or sponge, if necessary. Then rinse off with a water system. Rinse tools after use with water.

Do not leave ABBAClean permanently on the surface.

This treatment can be repeated if the surface is heavily soiled.

In oily pollution we recommend ABBAskim.

For a long-term-protection, we recommend to apply ABBAmousses or ABBAmousses plus on the cleaned surface.

Consumption: 1 Litre per approximately 5m² / 0,2 Litre/m²

When applied correctly, ABBAClean is not harmful. Observe normal safety regulations.

STORAGE AND EXPIRATION

Can be stored for several years in its original packaging and protected against frost. Keep away from foodstuffs, beverages and animal feed.

Disposal: Avoid spilling in ponds or streams as ABBAClean may be harmful for aquatic fauna. Rinse tools after use with water.

Do not empty into drains. Dispose of only completely emptied containers.
