ABBAmousses is a product designed to keep buildings and their surroundings clean whilst fighting against micro-organisms like moss, algae, lichens and red traces, developing through damp and rain.

ABBAmousses is a product without any risks for materials. Biodegradable 98 % .

APPLICATION FIELD

ABBAmousses does not present any danger for the surfaces and materials upon which it is applied, it can be used on a wide range of materials:

Roofs: tiles, natural slates, painted or unpainted fibre-cement tiles, shingles, bitumen, all types of wood, metallic or translucent tiles, domes, etc.

Walls/Fencing: all types of plastering, roughcast, quarry stone, bricks, boarding, wood, metal, plastic, patios, monuments, conservatories, alleyways, benches, tennis courts, etc.

HOW TO APPLY

ABBAmousses can be easily sprayed or applied with a brush or a roller. ABBAmousses must be applied upon dry or slightly damp materials (morning dew) and with no risks of rain for at least 24 hours and at temperatures of min. +3°C. We suggest Birchmeier brushes (available with us). Over high heat with direct sunlight ABBAmousses should not be used (danger of evaporation).

The surface must be swept clean (use Piassavabroom). Remove dense moss formations with a scraper. If very dirty, especially in the facade area, we recommend a pretreatment with ABBAclean.

Although it is not dangerous for vegetation, it is advised to protect all plants and vegetation located near the treatment zone.

Avoid spilling in ponds or streams as ABBAmousses may be harmful for aquatic fauna. Rinse tools after use with water.

Never rinse the treated surfaces with water.

Consumption: 1 Litre per approximately 5m² / 0,2 Litre/m² depending on the porosity and contamination of the underground.

When applied correctly, ABBAmousses is not harmful. Observe normal safety regulations.

STORAGE AND EXPIRATION

Can be stored for several years in its original packaging and protected against frost. Keep away from foodstuffs, beverages and animal feed.

Disposal: Avoid spilling in ponds or streams as ABBAmousses may be harmful for aquatic fauna. Rinse tools after use with water.

Do not empty into drains. Dispose of only completely emptied containers.

COMPOSITION

Prepared on the basis of quaternary ammonium salt in aqueous solution. ABBAmousses does not contain chlorine, sulfate or acid.

The surfactants meet the criteria of the detergents (ChemRRV) with respect to degradability.

Active substance: Quaternary ammonium compound, Benzyl-C12-18-alkyldimethyl-, Chloride 24.5 g/l, PH value 8
